

LIABILITY WAIVER AND RELEASE

I understand, and am fully knowledgeable of the dangers and hazards that are associated with operating a motorcycle, including serious bodily injury, paralysis, dismemberment, property damage, loss of personal property, or death. I hereby accept all risks of personal injury and property damage or loss arising from my participation in a *Motorcycle Tours Northwest* tour and I, my dependents, heirs, and agents hereby release and hold harmless, and promise not to sue against and indemnify *Motorcycle Tours Northwest*, its owners, its employees, and agents from any and all claims, including claims of death, bodily injury, illness, property loss or damage, however cause, arising from or related to a *Motorcycle Tours Northwest* tour even if arising from the negligence of the releases or others.

I am duly licensed and over the age of 21 and possess the abilities and the skills necessary to operate a motorcycle in a safe and cautious manner, and I accept full, complete and personal responsibility for the safe operation of my motorcycle while participating in the Tour. I know of no physical or mental impairments that may affect my safety or the safety of my passenger or others.

On every *Motorcycle Tours Northwest* tour, the safety of our participants and employees is of the utmost importance. If at any time I feel that motorcycles are being operated in an unsafe manner, or that the safety is being compromised in any way, I will immediately bring it to the attention of an employee of *Motorcycle Tours Northwest* so that my concern may be addressed. I acknowledge that *Motorcycle Tours Northwest* STRONGLY URGES WEARING A HELMET AT ALL TIMES and other safety gear such as boots, gloves, jackets, and eye protection, regardless of individual state laws that may not require the use of a helmet and other safety gear. I certify that I will not at any time during the Tour operate a motorcycle under the influence of alcohol, narcotics, or any substance which may impair my ability to operate a motorcycle safely. Any participant found to be operating under the influence of any such substance may be dismissed from the Tour immediately, without refund or credit of any kind.

I agree to hold *Motorcycle Tours Northwest* harmless for any failure, delay, acts of omission and any resulting loss or damage occurring during the Tour, or as a result of the Tour, through the actions of third parties, including, but not limited to, the operators of hotels, restaurants, and other suppliers and vendors engaged by *Motorcycle Tours Northwest*. This includes damage or loss due to governmental action, weather, mechanical breakdown, equipment failure, labor disputes, sickness, acts of War, acts of God, or other causes beyond the direct control of *Motorcycle Tours Northwest*.
